The Tender should be in a strong sealed cover marked as tender for the supply of Banana . The last date of tender submission is 04-04-2016 before 4-00 pm at JNV Mudgal. The interested tenderer can drop their tender / sent their Tender in advance. The tender will be opened in the office of the Principal JNV mudgal on 05-04-2016 at:10:00 AM
02. The participating Tenderers are requested to furnish the reasonable Rates for reasonable quality.
03. There should not be any over writing or correction in the Tender. If absolutely necessary it should be attested with full signature of the Tenderer.
04. The delivery should be made to the JNV mudgal at their own cost.
05. Rates quoted should include all the packing, Transportation, loading & unloading etc,
06. The Quantity shown above may be increased / decreased at the time of placing order as per convenience of the Vidyalaya.
07. Successful tenderer should supply the Banana regularly within a day's from the date of receiving the supply order.
08. Tenderer should enclose the Demand Draft for Rs.3000 /- as an EMD in favour of Principal JNV Mudgal, drawn on State Bank of India Mudga. The successful Tenderer should pay Rs 3000/- as security deposit.
09. For unsuccessful tendere EMD DD will be returned on the Tender opening day after preparation of Comparative statement or next working day.
10. For successful tenderer the EMD amount and Security deposit of Rs. 5000/- deducted from the 1<sup>st</sup> Month of bill and will be retained till 31<sup>st</sup> March 2017.

11. Tenders which are not enclosed EMD amount will not be considered.
12. The undersigned does not bind himself to accept the lower tender and reserves the right to accept/reject tender in whole or in part without assigning any reason there off.
13. The rates quoted are applicable till 31<sup>st</sup> March-2017.
